Improve student learning through timely intervention and support for student success. Success will be measured by 1% increase in the graduation rate and a 1% increase in course pass rates when compared to previous year.

Goal #1 Action Steps

1. Hire two student advocates to work with and assist struggling students to focus on learning gaps (77,000).
2. Hire a student attendance advocate to work with students (36,000).
3. Offer 3 buyout periods for teachers to work with Edgenuity students (35,000).
4. Offer 7 classroom buyouts to decrease student/teacher ratios as we experience population growth (83,000).
5. Hire a mental health specialist to work with students who struggle (27,000).
6. Purchase licenses for Panorama to enable teachers and counselors to have access to student information which identifies struggling students (8,248).
7. Supplement textbook purchases including consumable workbooks to aid instruction and increase student achievement (\$10,000).
8. Provide Education Leadership Development for LIA Program (2,000).

Goal #2 Action Steps

1. Provide opportunities for teachers to collaborate during the summer to plan assessment for learning gaps and standards based instruction (4,000).
2. We will continue to train our teacher leadership team to support content teacher teams, conduct professional development for faculty, assess learning gaps, remediate, and improve student learning (7,000).
3. Provide opportunities and substitutes for teachers to attend conferences and to work collaboratively (4,000).
4. Provide a writing support program (Unicheck) for teachers to utilize and support students in content area writing (2,200).
5. Provide licenses for Shmoop ACT and Aspire test prep (3,750).
6. Provide classroom technology and TV Display screens, webcams, microphones, STEM Equipment, lab materials, calculators, music, and other content related equipment (80,000).
7. Provide opportunities for collaboration and development by the Teacher Leadership Team for school Curriculum vision and PLC's during the summer (1,500).
8. Provide specific training for Teacher Leadership Team with Solution Tree Conference to strengthen PLC's (8,000).
