5. Provide licenses for Shmoop ACT and Aspire test prep.	3,750
6. Provide classroom technology and TV Display screens, webcams, microphones, STEM Equipment, lab materials, calculators, music, and other content related equipment.	30,000
7. Provide opportunities for collaboration and development by the Teacher Leadership Team for school Curriculum vision and PLC's during the summer.	1,100
